Since its passage, the IRA has brought nearly half a billion dollars of federal investments directly into the state of Wisconsin. That funding has created hundreds of new jobs, jump started new clean energy projects, and accelerated Wisconsin's transition to a clean energy economy—and it's only been 365 days. The Wisconsin legislature must see this influx of federal funding as an opportunity and work to support the clean energy transition to build a healthy, prosperous and more affordable future for all Wisconsinites.

### ABBY NOVINSKA LOIS, Executive Director, Healthy Climate Wisconsin

In addition to its sweeping economic and clean energy benefits, the Inflation Reduction Act is an important public health measure that will significantly reduce pollution and create a Wisconsin where more people can enjoy long, healthy lives. Wisconsin has already received

\$1.5 million for air monitoring from the IRA. This air monitoring network will generate real-time and publicly accessible data for BIPOC (Black, Indigenous, and People of Color) and low-income neighborhoods to identify local pollution and protect community health. By 2030, the IRA is expected to prevent 3,800 premature deaths and 99,500 asthma attacks.
